### ABOUT THE PLAY:

Joyce, Effie and BB are cowgirl goddesses on Mount Olympus who lament what they see down on earth. It's a cowboy's world. Cocky steer-ropers have stolen the spotlight for long enough. The goddesses decide to use their considerable supernatural powers to give rise to a Cowgirl Revolution. When they discover Cassidy Clark, a talented, charismatic loner from Okotoks, Alberta, they know they have found the barrel racer poised to lead their cause. The three goddesses appear to her one day, offering her all the gifts she will need to earn her first buckle at the Canadian Finals Rodeo championship. We follow Cassidy atop her trusty mare, Starbright, as she rises to the top of the circuit, throwing back shots of Jack Daniels and two-stepping along the way. Cassidy wrestles with her newfound fame, and just how far she will push herself and Starbright in pursuit of their dream.

#### **ROLES / RANGES:**

**CASSIDY: Female:** (20's) Barrel racer. Loner, determined, got fire in her. Strong and independent but also vulnerable due to her Gran's recent death. Cassidy is a tough-as-nails jock, and the role is heavily movement-centred.

**JED:** Male: (20's) Professional Cowboy, a tie down roper. A ladies' man. Can do a proper two-step. This actor also plays the Rodeo Announcer and other rodeo horses. The role is heavily movement-centred.

NOTE: Actors applying for the roles of CASSIDY and JED should be excellent movers; stamina and flexibility are required for both roles. Please indicate if you have dance, circus, gymnastics (or any other athletic training) on your submission.

#### COWGIRL GODDESS:

**BB**: late twenties, intuitive, psychic. **JOYCE**: 40s, 1980's power-cowgirl.
